

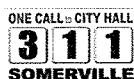
Please be advised that the Executive Director of Strategic Planning and Community Development is in receipt of your Board Order # 189417 dated May 13th, 2010 requesting Inspectional Service Division inspect the Miller and Sacramento Street area for a severe rodent problem and inspect all food establishments and business in that area, also requiring them to demonstrate the proper disposal of trash, waste, cooking oil, etc and site any establishment found to be in violation.

In response, the Inspectional Service Division inspected the entire site with our Health Inspectors, speaking to several residents, business and food establishments. The owner of one of the food establishments was cited, and instructed to clean, remove and dispose of their waste, food oil, etc. in the proper manner. The entire area was baited for rodents.


Aldermen Desmond, Taylor, White, Sullivan and Connolly,

Please be advised that the Executive Director of Strategic Planning and Community Development is in receipt of your Board Order # 190231, dated October 14, 2010 requesting Inspectional Service Division to determine how many businesses are operating at 45-49 Webster Avenue.

In response, please be advised the Inspectional Service Division sent the Neighborhood Impact Team to inspect the properties at 45, 47 and 49 Webster Avenue and stated there are three separate businesses located at this property. Both 45 and 47 Webster Avenue are in compliance. The establishment at 49 Webster Avenue may have 4 vehicles over their limit. This is being researched and will be addressed if found to be in violation.
