**Description:** How many people are actually prepared to weather a major storm, create an emergency plan, and dodge zombies? In the Zombie Disaster Preparedness Game, teams of 4-6 players race to complete skillbuilding and playful challenges while capturing zombies. The game occurs within a 10 block walking radius, sprinkled with a dozen thematic stations. Challenges include: correctly practicing CPR, successfully operating a HAM radio, and swiftly pelting zombie cutouts with nerf guns. In between challenges, players can earn bonus points with trivia questions about disaster preparedness and by making creative contributions like dance videos. The 1.5 hours of game play culminates in an awards ceremony and Thriller dance routine by the zombies- at the site where we are applying for the permit. The game is meant to be played by 100 people with about one dozen supporting nonprofits or community leads who offer competitive activities at stations.

Unfortunately, topics like disaster preparedness are often difficult to grapple with meaningfully. People should be prepared for disasters, but they often don't have a chance to practice those skills in a useful way. By baking the learning elements of disaster preparedness into a free and public game, we have an opportunity to shift this topic from one of catastrophe to connection. Dealing with disasters by sharing resources and helping neighbors is ultimately a relational experience. Playing a public game that prepares us for a disaster helps us discover the community resources around us.

Dear Rebecca Michelson,

This letter serves as official notice that your **Interrelated Media Project** grant application #30033-LCC018 has been approved by the Somerville Arts Council in the amount of \$1,700. Congratulations! All of us at the Arts Council look forward to seeing your work and appreciate your contribution to the cultural life of Somerville.

This year the Arts Council had \$61,035 to allocate to 110 grant applicants requesting a total of \$217,180. A total of 57 applicants received funding in support of a diverse range of projects, fellowships and educational programs. Though the Council tried to fund as many projects as possible, in many cases we could only award partial funding. We hope that our support will enable applicants to raise matching funds; however, we recognize that some applicants may have to scale down their original proposals. Grant money is paid in the form of a reimbursement of your expenses relating to your project. Please read the enclosed memo ("How do I get my money?") as a reference when submitting paperwork. If you have any questions, you should call at the Arts Council office before spending money on your project or requesting funds.
