Dear Board Members:

Preliminary approval is recommended for the petition and plan of NSTAR Electric Company d/b/a Eversource to install 8 feet of three (3) inch PVC conduit. The conduit will be laid at 59 Otis Street from pole 264/8. Pole 264/8 is approximately 35 feet east of Wesley Street. Otis Street is a public way of Somerville, MA.

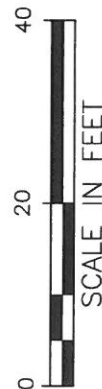
