Councilor Burnley expressed disappointment that the \$200,000 request for an alternative non-emergency response unit was not included in the budget, therefore, he will not vote for the budget.

Councilor Wilson moved to waive the reading of the agenda items marked as 21-C through 21-G and 21-I through 21-AM. Those items were approved, and 21-H and 21-AN were placed on file.
