File ID 24-0014: Requesting approval to accept and expend \$76,867.00 with no new match required from The Massachusetts Executive Office of Elder Affairs to the Council on Aging for social, educational, and physical wellness programming.

Dear Members of the Finance Committee,

The Council on Aging requests your approval to accept and expend \$76,867.00 from The Massachusetts Executive Office of Elder Affairs. This money was awarded to the city on November 15, 2023. There is not a match required for these funds.

The Council on Aging receives this funding from The Massachusetts State Budget in pursuant to M.G.L. 19A § 1. Based on the formula, \$14 per senior resident of Somerville, this is half of the expected FY 2024 funding. Funding is provided to ensure all older adults and their caregivers have access to programming, tools and resources needed to embrace the aging process. Funding is used to: offset the cost of large celebrations, allow all physical exercise programming to run at no cost, fund monthly entertainers at our centers, and to provide a variety of social, educational and mental health support programming.

Dear Members of the Finance Committee,

The Council on Aging requests your approval to accept and expend a \$3,600 grant from The Massachusetts Councils on Aging to offset the cost of our Memory Café. This grant was awarded to the city on December 20, 2023, and must be expended by June 30, 2024. There is not a match required for these funds.

The grant funds will be used for the Council on Aging's Memory Café. A Memory Café is a safe space for those with cognitive decline, and their caregivers, to attend a social or educational event and to gain support from others in a non-judgmental setting. Led by our social work team, the Café is held once per month and consists of an activity and light dinner. Activities include art therapy, flower arranging, and interactive music performances.
