Describe the reason for the work, and the intended beneficiaries:

Updated: This project will allow Cambridge Network Solutions to interconnect with a City of Somerville Conduit that is located within the sidewalk and the Zayo (formally MFN) manhole system. The newly proposed 4-inch underground conduit will provide a connection to each of these structures. Additionally, this will provide a path way for Cambridge Network Solutions, LLC to install a new 48 fiber tie fiber optic cable that will run within the conduit and provide a connection for the City of Somerville to their existing network located in Somerville City Hall. This tie cable will splice back into a CNS 864 fiber cable that the City has 48 strands of fiber in it for their use. This back-bone deal is part of a larger agreement with the City of Somerville MA. The location of this proposed trench is based on the vicinity and to the City of Somerville existing conduit that runs to City Hall.
