Chair Sait provided background on the order, explaining that some participants who were using scooters and mopeds did not interpret the "NO MOTORIZED VEHICLES" sign as applying to those modes of transportation. Director Rawson mentioned that the Mobility team is working on the most effective ways to communicate with users of community paths, including exploring speed control measures and adding additional signage.

Councilor Sait asked when the updated signage could be expected. Director Rawson explained that the sign changes could occur between now and September 2025, with the final decision on the updates coming from Director Rinfret and parking.

Councilor Wilson raised the concern of how to address the issue without limiting mobility devices. They suggested including graphics on the signs to clarify which modes of transportation are allowed. Director Rawson responded that they are currently discussing both plain language and graphic designs, with the goal of making it clear which vehicles and behaviors are being regulated.
