The Green Line Extension (GLX) project is an initiative of the Massachusetts Department of Transportation (MassDOT) and the Massachusetts Bay Transportation Authority (MBTA) to extend Green Line service from a relocated Lechmere Station in Cambridge to Union Square in Somerville and to College Avenue in Medford. As part of the public transit improvements, several water, storm drain and sanitary sewer utilities will be relocated and/or new services provided to new train stations in Somerville, MA. Attached to this letter are narratives, a spreadsheet, and 11x17 plans that depict and describe instances where a municipal utility (water, drain, and sewer) is proposed to be constructed and or relocated in a permanent condition within the City of Somerville's Public Right of Way as part of IGMP#2, IGMP#3, and IGMP#4 packages of the GLX project.

As a result, MBTA is petitioning the City of Somerville for Grant of Locations at the following locations.

- Washington Street below and immediately to the east the existing RR Bridge
- The north end of Horace Street
- Within Bennett Street and the south side of the Prospect Street Bridge
- Inner Belt Road between 70 and 200 Inner Belt Road

There will be several other utility relocations and new services proposed as part of the project in either subsequent IGMP packages or by third party utility companies for electric, fiber, gas, and telecommunication utilities, however, the Grant of Location petitions for those relocations and services will be performed at a later date and or by the third party utility companies.


