MEMORANDUM

Subject: "Power Push" Event Application, City Addendum

Dear Members of the Board of Aldermen:

Staff from the Department of Public Works, Police and Fire Departments, Traffic and Parking, and the Office of Communications have identified an action plan for the proposed Power Push fundraiser which each department feels adequately addresses the needs of the neighborhood for this event. The plan for each department is outlined below, and a Traffic Management Plan is attached for your review.

While the event itself will utilize no more than a parking lane or one lane of traffic, it will bring with it some spectators and foot traffic, and for the safety both of the spectators and Jerry Bowser, it is advised that vehicle traffic not be allowed in this area for a brief period of time as the procession passes. This closure will not last more than an hour, however it is expected that the total road closure will last approximately 30 minutes. Parking will be restricted on the eastbound side of Broadway from noon until 4 p.m. Mr. Bowser has expressed his interest in and intention to speak with each business owner on this stretch of Broadway to address questions and concerns leading up to the event so that we can better plan for address any needs they may have.

Traffic and Parking

- Post "No Parking" signs on eastbound side of Broadway from Liberty Avenue to Rogers Avenue. No Parking effective 12 p.m. to 4 p.m. Saturday.
- Relax Resident Permit Parking on adjacent streets for the duration of the No Parking restriction.
- Enact Traffic Management Plan (see attached) at 2:30 p.m., as follows:
 - Total closure of Broadway from Powderhouse Rotary to Boston Avenue/Rogers Avenue from 2:30 to approximately 3:30 p.m. (with the





expectation that the event will be completed by 3:15 p.m. and the road will reopen).

- Eastbound traffic will be detoured onto Warner Street and then to Boston Avenue
- Westbound traffic will be detoured onto Boston Avenue and to Warner Street to reach Powderhouse Rotary.

Police

- The Somerville Police Department will provide two (2) officers for a four hour period.
- Officers will assist with traffic flow in front of The Pub beginning at 2 p.m. as a small (10' x 5') stage is set up in the parking space directly in front of their establishment for the finish line ceremony.
- Officers will be stationed at Boston Avenue and Powderhouse Rotary intersections for the duration of the total road closure.
- Auxiliary Officers will supplement SPD officers at intersecting side streets (Liberty Avenue, Bay State Avenue, Willow Avenue, Josephine Avenue and Rogers Avenue, as determined by SPD).

DPW

- Place barriers for road closures according to the attached TMP.

Fire Department

- Fire Department has been asked to hang a flag from a ladder truck as part of the ceremony.

They have both battled through numerous surgeries over the past year. Monies raised from this Power Push Event will assist the Norden Brothers with medical bills and long term care.

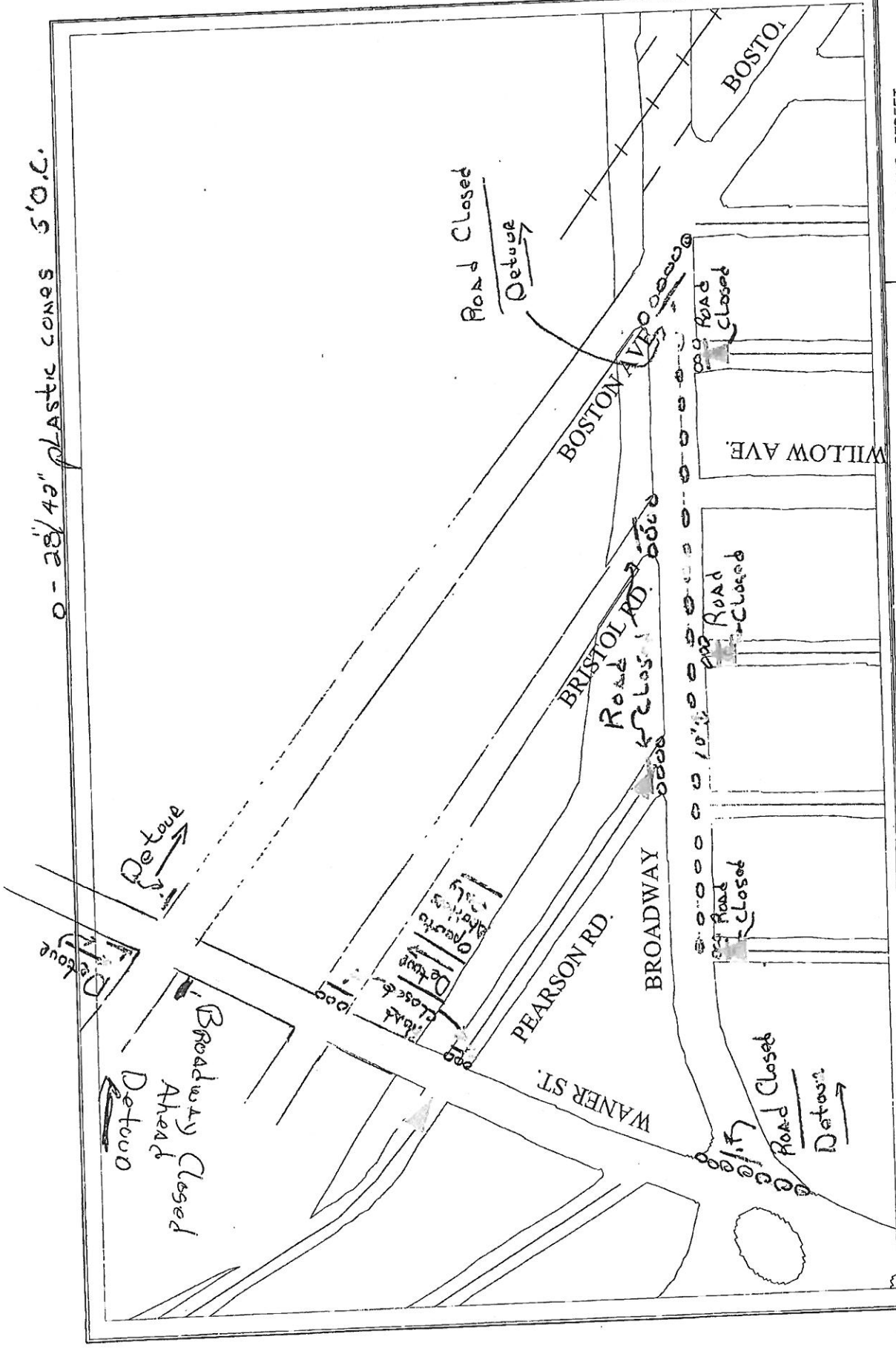

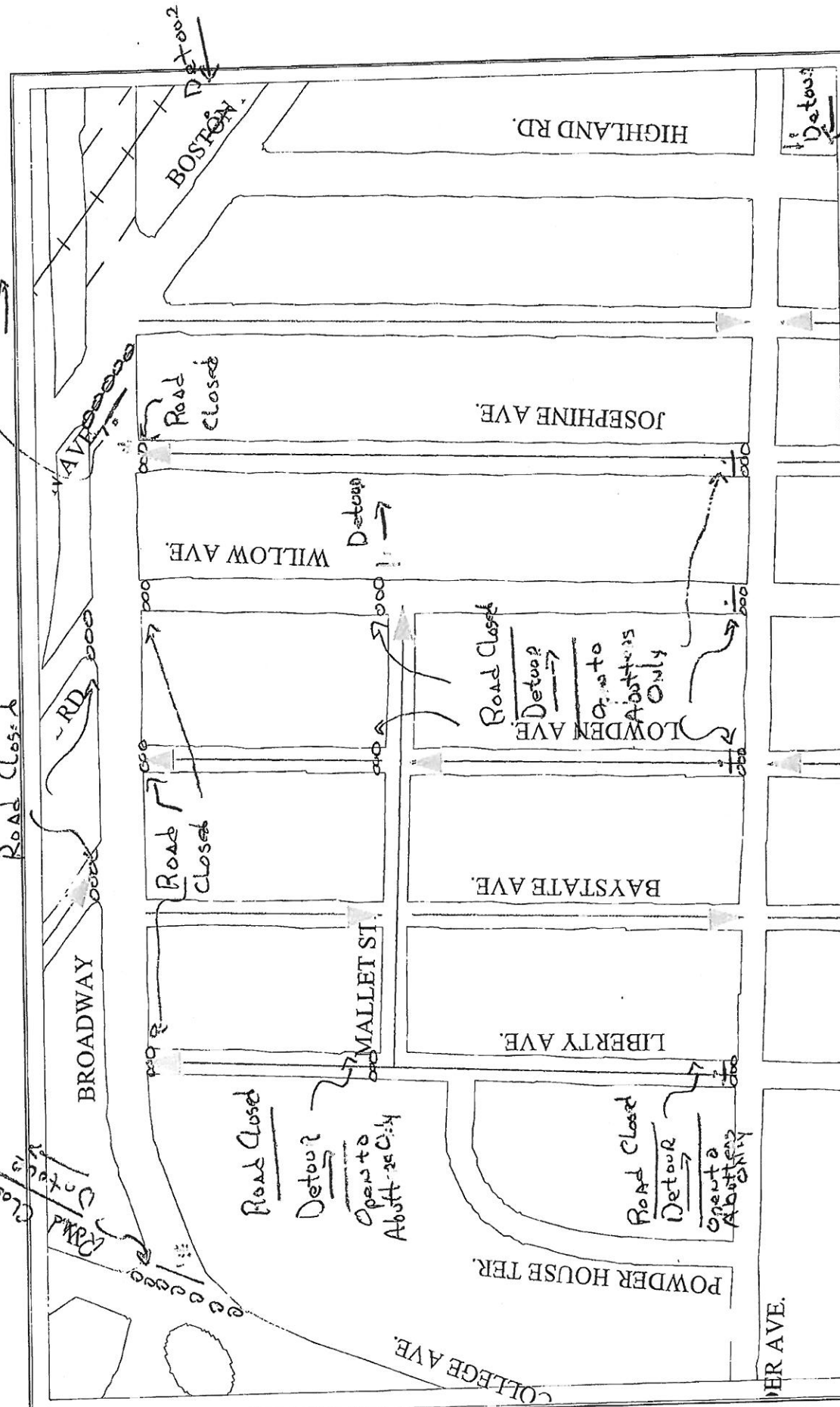
