Dear Ms. Burbidge,

I write to apply for a position on the Affordable Housing Trust as a representative of Community Action Agency of Somerville, Inc. (CAAS), a Somerville non-profit organization. I have also committed to serving on the Board of Directors of the Somerville Community Land Trust, a new entity which is presently in the process of being formed.

- 1. My interest in serving as a Trustee stems from my experience of the work of the Trust over the past five years. During this time CAAS has been the recipient of AHTF funds that have greatly advanced our ability to serve low-income city residents. I have also worked collaboratively with other Somerville agencies with similar experiences, and I have great respect for the important role played by the Trust.
- 2. I represent CAAS, whose mission is to reduce poverty among local families and individuals while working to counteract and whenever possible, eliminate the societal conditions that cause and perpetuate poverty. We serve low-income residents of the City, primarily through our Head Start, Homelessness Prevention, and Volunteer Income Tax Assistance programs. While I acknowledge there are no 'assigned positions' on the Trust for non-profit agencies, it should be noted that one of my predecessors, Jack Hamilton, served on the Trust for many years.
- 3. While I do not have direct experience with affordable housing development, I have participated in countless discussions around this topic. I served as a member of the Union Square LOCUS Leaders group, a primary purpose of which was discussion of the provision of affordable housing as a community benefit stemming from the Union Square redevelopment. Nearly all of CAAS' clients are residents of affordable housing, whether private or public, and I have a solid understanding of the challenges they face and the regulations under which they live, but also an understanding of the restrictions and challenges faced by affordable housing owners and managers.

The mission of CAAS is to reduce poverty among local families and individuals while working to counteract, and whenever possible eliminate, the societal conditions that cause and perpetuate poverty.

- 4. I have extensive experience with budgeting and financial management. I have been a non-profit executive director for nearly fifteen years. Before that I was a corporate attorney. Both of those positions require an ability to read financial statements and to prepare and work within budgets.
