He commented that the school guidelines issued by the State last week were unreliable and do not provide the tools needed to do the job safely. He said he wants to ensure that all available safety measures are utilized to make it safe to reopen the schools, and improving ventilation, along with other protocols like masks and social distancing, will help mitigate the risk of contracting the virus. He outlined a plan to test students and staff, saying 23 different options were reviewed. A policy recommendation is now before the School Committee. Director of Infrastructure and Asset Management Rich Raiche presented a school building assessment and estimated that the cost of remediating the buildings would be approximately \$7.5 million, \$3 million of which would come from the CARES Act. Several councilors gave their thoughts on the matter and expressed support for the additional appropriation of \$4.5 million.
