Last April, a real estate developer started seeking permission from the City of Somerville to demolish the historic church at 125 Highland Ave, shown above. This building is on the National Register of Historic Places, but because it is not (yet) protected by a legally-binding "Local Historic District," the most that the Historic Commission could do at that time was to institute a 12-month "demolition delay" period, with the hope to negotiate with the developer in the meantime. Unfortunately, those negotiations went nowhere, and the developer is still charging ahead with their demolition plans as soon as the delay period ends in late April. Alongside many neighbors who reached out, I believe this building is a rare opportunity for renovation and adaptive re-use, ideally as mixed-income affordable housing. This is an ideal project for funding from Somerville's Community Preservation Act, which is earmarked for both historic preservation and affordable housing. Over the past year, Councilman Ben Ewen-Campen has filed multiple orders advocating for this approach. To help prevent this short-sighted demolition plan, Ben has been working with the Administration to have this building officially designated as a Local Historic District, which would block demolition and instead encourage renovation of this historic structure.
