197086 - Public Event Permit, Assembly Row Assembled Arts Market, 1 Assembly Sq Drive, Saturdays Jun 7-Sep 13, 9AM-4PM.:

The applicants appeared before the committee and stated that approximately 25-50 artists would participate in the event along with 3 food trucks. The Director of Traffic and Parking has not signed off on the permit due to concerns that there are no meters in Assembly Row. The meters are in the process of being bagged and installed within the next week. There will be a \$35 per day/per meter fee. *The committee amended the item for the location to move to the Block 5 parking lot.*
