## **197956** - That the Chief of Police appear before the Public Health and Safety Committee to report on the current and future progress of the Police Dept.:

Chief Fallon reported that crime in the city is trending downward, but noted that there is a regional increase in airbag thefts. Chief Fallon spoke about increased walking patrols, community policing, training programs, the use of social media and the department's work with the schools and the city's youth.
