The City of Somerville respectfully requests an extension date for the return of Certification No. 290251 dated 05/06/09, for 9 Permanent Reserve Firefighters. In light of anticipated cuts to the fiscal budget, the City had taken no actions taken during the time this certification was issued and its closing date.

However, the City was able to pass a balanced FY10 budget without layoffs in the fire department and we would like to proceed with creating a reserve list. At least one person on the list, currently serving in the military, has been offered a position conditionally. Moreover, there are currently four involuntary retirements pending a medical review panel and 27 firefighters eligible for full retirement during FY10.

To Whom It May Concern:

On February 11, 2010, HRD received a letter from the City of Somerville dated February 8, 2010, requesting an extension for the return of Certification No. 290651.

On February 24, 2010, I received another letter from the City, requesting an extension. On the same date I received an e-mail from Matthew Buckley asking for a response to the request for an extension. The February 8, 2010 and February 24, 2010 letters did not contain sufficient information for HRD to approve the extension. Accordingly, I e-mailed Mr. Buckley to inform him that additional individuals would need to be considered, as the eligible list had changed.

On the same date, I received a phone call from Mr. Buckley, in which he informed me that the City had already made conditional offers of employment to ten individuals and two on active military duty. I asked Mr. Buckley to send me detailed information regarding the conditional offers of employment.

On February 25, 2010, I received a letter also dated February 24, 2010, from the Appointing Authority detailing the individuals to whom conditional offers of employment had been made, and the dates these offers were made. This information was sufficient for HRD to approve an extension for the return of the certification. Accordingly, on February 25, 2010, I approved the extension request through April 1, 2010, and stamped the request to reflect this approval.
