Preliminary approval is recommended for the petition and plan of NSTAR Electric Company d/b/a Eversource to install approximately 66 feet of conduit, (2) 4 inch PVC, in Highland Avenue, running Northeasterly from Manhole #14703, approximately 171 feet east of Trull Lane. Highland Ave is a public way in Somerville, MA.


