189727 - That the Director of SPCD Report in Writing to the Committee on Housing and Community Development on the Results of the Meeting with the Magoun Square Business Owners and the Ward Five Alderman, to Discuss Parking and Other Issues Affecting the Decline in Business in Magoun Square.:

Alderman Gewirtz expressed concern regarding Walmart's employee history and feels that small businesses would be hurt. Mr. Glavin informed the members that Walmart has not submitted a proposal and that if and when they do, a special permit would be required from the Planning Board.

Alderman Sullivan's motion *that the Executive Director of the Office of Strategic Planning and Community Development research studies regarding the impact of Walmart on other communities and report the findings to the Board of Aldermen during the first quarter of 2012*, was approved.
