VIOLATION NOTICE TO OFFENDER:

You have the following alternatives with regard to disposition of this matter: (1) You may elect to pay, either by appearing personally or by an authorized person before the hearing officer c/o City Clerk of the City of Somerville during regular business hours, or by mailing a check, money order or postal note to the Clerk of the City of Somerville within twenty-one (21) days of the date of this notice. This will operate as a final disposition of this matter, with no resulting criminal record. OR (2) You may elect to contest this matter in a non-criminal proceeding by making a written request to the hearing officer c/o City Clerk of the City of Somerville for a hearing before the municipal hearing officer within (21) days of the date of this notice. Failure to request a hearing within twenty-one (21) days shall forfeit your right to a hearing. Enclose a copy of this citation. Any person aggrieved by a decision of the hearing officer, after a hearing, may appeal to the Somerville District Court.

If you fail to pay the scheduled assessment; fail to request a hearing before the municipal hearing officer; or fail to appear at the time and place of the hearing within the prescribed time period, you may have a criminal complaint application filed against you and/or the fine may be levied in the form of a tax against the property and/or the City of Somerville may deny any application for, or revoke any of your permits, and/or a municipal charges lien may be placed on your property. Further you shall be found responsible for the violations as stated in the notice to appear.
