Request for Somerville Voter Resident Signatures to Hold Town Meeting

My name is Parama Chattopadhyay, Business Owner and Resident of Out of the Blue Community Arts, a 501c3 non-profit organization, currently located in the Arts at the Armory building (the "Armory") in Somerville, MA. "Out of the Blue" has been operating in the Armory since October 2019, and is known for its lively local art exhibits, music shows and literary events.

The Armory currently houses a total of 8 small arts-based businesses, each business named as a "tenant" for the purposes of this petition. Tenants have been solely dedicated to promoting the arts in Somerville and the surrounding communities since 2005. In 2021, the City of Somerville has taken over the Armory through the process of Eminent Domain. The stated purpose of this takeover was to provide financial support to the Armory and to help artists who have been "hit hard" by the COVID-19 pandemic. The status of the current tenants of the Armory is now unclear and there has been little explanation from the City of Somerville. As it now stands – the tenants have been told that they are subject to eviction at the City's whim.

In addition, the City of Somerville has struggled in its management of the Armory since the takeover – failing to provide sufficient maintenance and janitorial services. Some tenants have complained of heavy-handed and arbitrary treatment by the City of Somerville. Exacerbating the situation, the City of Somerville has not been transparent with regards to its plans for the Armory (beyond hiring an “arts consultant”) and has failed to adequately communicate its plans for the Armory and how the current tenants fit into these plans.

Based upon the above, I propose that the City of Somerville hold a town hall meeting to discuss the Armory’s management and the City of Somerville’s vision for its future. I am therefore publishing this petition specifically for Somerville residents to sign, asking for a Town Hall Meeting. Your support is appreciated, as a minimum of 50 signatures and most optimally 200 signatures from Somerville voting residents would require that the City of Somerville host such a meeting.

The purposes of the Town Meeting would be to:

1. Ensure that Armory tenants are not treated arbitrarily and that current Armory tenants will not be evicted or intimidated to leave before (at least) June 31, 2022.
2. Discuss fair and unbiased treatment by the “arts consultant” to be hired by the City in April 2022. The City promised public discussions about who the consultant would be, but has failed to provide any information about this consultant since the one and only public tenant’s meeting with City management on September 23, 2021.
3. Discuss fair rehoming assistance for current art businesses at the Armory who are at great risk of being displaced on or before June 31, 2022. This is especially important since many of the tenants have original leases that spanned over the next 2 to 5 years and arranged their finances based upon that commitment.
4. Discuss having a proper janitor and maintenance professional at the building. Currently, the City of Somerville has not hired a janitor, despite promises of doing so. To underscore the importance of proper building maintenance, two tenants were recently stuck in the
