Councilor Ewen-Campen stated that he has supported similar grants in the past, but his thinking has since changed. Councilor Wilson commented on the numerous requests for traffic enforcement but said that data is clear on the inequity of who is being stopped. Chief Femino stated that the 3-stop interaction per hour is not a police directive but is a grant requirement. He added that if the grant is accepted, he would put out a policy to be followed by officers. Councilor Wilson asked about sending warnings and tickets via mail rather than conducting traffic stops on state roadways and Chief Femino explained that in person traffic enforcement is effective. Councilor Gomez Mouakad asked if Chief Femino would be amenable to providing quarterly reports and the chief had no objection. Councilor Gomez Mouakad continued by saying that there is some fear from the Latino community among those who need to drive and don't have licenses. She asked what the policy is in that situation and Chief Femino stated that if a person without a license is stopped, it might warrant a warning, a summons, or some other action and is dealt with on a case-by-case basis. Councilor Gomez Mouakad sponsored RSJ Director Denise Molina Capers to speak. The Director said that combining policing and public safety requires taking several criteria into account through a community approach. Councilor Clingan said that he hears that Somerville is like the wild west because of a lack of enforcement and he asked what the grant entails and Chief Femino explained the different campaigns within the grant and said that stops are made based on infractions being observed by officers. Councilor Clingan asked how many of the 800 people pulled over last year were arrested and Chief Femino will provide the information. Councilor Kelly commented that thousands of people have spoken with her in favor of safer streets through street design, not by policing.
