

# ROCK AND RUN - TURN BY TURN

BELOW IS A PRELIMINARY TURN BY TURN OF THE RUNNING COURSE FOR THE ROCK AND RUN. PLACEMENT OF OBSTACLES/CHALLENGES/MUSIC WILL BE DETERMINED PENDING CONVERSATIONS WITH ASSEMBLY ROW AND THE CITY OF SOMERVILLE. OUR INTENT IS TO USE SIDEWALKS AND SHOULDERS AS MUCH AS POSSIBLE TO AVOID CLOSING ANY MAJOR ROADS DOWN

- THE ROCK AND RUN WILL BEGIN IN THE TRIANGLE LOT ON ASSEMBLY ROW. FOLLOWING A QUICK ROUTE GRAND UNION BOULEVARD. RACERS WILL TAKE A LEFT ON GRAND UNION BOULEVARD AND THEN ONTO THROUGH THE TRIANGLE LOT, RACERS WILL TAKE A LEFT ON REVOLUTION DR AND HEAD TOWARDS ASSEMBLY SQUARE DRIVE. RACERS WILL HUG THE SHOULDER ALL THE WAY TO MYSTIC AVE
- AVE. RACERS WILL BE CONFINED BY CONES AND ROPE ALONG THE SIDEWALK AND MAKE THEIR WAY ALL ONCE AT MYSTIC AVE, RACERS WILL CROSS THE INTERSECTION AND HUG THE SIDEWALK ALONG MYSTIC FHE WAY UP MYSTIC AVE BEFORE TAKING A RIGHT ON MIDDLESEX AVE.
- ASSEMBLY ROW SIGN AT THE INTERSECTION OF GRAND UNION AVE. HERE, RACERS WILL TAKE A RIGHT UP ONCE ON MIDDLESEX AVE, RACERS WILL STAY ON THE RIGHT HAND SHOULDER ALL THE WAY UNTIL THE GRAND UNION BLVD AND QUICKLY CROSS OVER THE STREET ONTO THE PATHWAY ALONG THE
- ONCE ON THE PATHWAY, RACERS WILL FOLLOW THE WATERFRONT, THROUGH THE AMPHITHEATER AND UP TOWARDS DRAW 7 PARK. RACERS WILL MAKE A LAP THROUGH DRAW 7 PARK BEFORE COMING STRAIGHT THROUGH ASSEMBLY SQUARE AND ROUTING BACK UP AND INTO THE TRIANGLE PARK
  - ONCE BACK IN TRIANGLE PARK, RACERS WILL HAVE A STRAIGHT CHUTE TO THE FINISH LINE
