Preliminary approval is recommended for the petition and plan of NSTAR Electric Company d/b/a Eversource to install approximately 61 feet of (1) 4-inch PVC conduit from utility pole # 7/1 to the building at 13 Alpine Street. The conduit will be laid in Alpine Street. Alpine Street is a public way in Somerville, MA.

This recommendation is made with reference to NSTAR Electric's Order for Conduits and Manholes dated December 3, 2018 and plan of November 3, 2018 upon stipulation that the Grant of Location is subject to: a reservation of rescission by the Board of Aldermen; indemnification of the City for all liability arising from said Grant; all permit procedures, conditions and approvals of municipal utilities; protection of existing infrastructure; and complete surface repair, restoration and maintenance. A public hearing will be required.

This conduit is necessary to provide power to 13 Alpine Street. Alpine Street is on the 5-Yr Street Moratorium list since 2016. The Street's restoration requirements are as follows: one continuous repair, must mill to meet existing pavement thickness, and a curb to curb, 12-foot wide patch on each side of the trench. This work cannot be performed during the winter moratorium effective November 16, 2018. The moratorium is to be lifted in April 2019, weather permitting.


