FIFTH ANNUAL STARLABFEST MUSIC AND ARTS FESTIVAL - JULY 19, 2014 TWO LOCATIONS EXPLANATION

32 PROSPECT ST. (PARKING LOT)

This is the location of the former Starlab Recording Co. music studio that has since been relocated by the City as part of the Green Line Extension program. The property now belongs to the City of Somerville and we have been informed that it will still be standing as a vacant parking lot at the time of the event. This is the location that we have hosted the STARLABFEST music festival for the past four years and we think it would be very special and appropriate to host it here one final time before the overhaul begins. We plan on hosting the Live Music portion of the event here.

Of course, we will hire any necessary Police and/or Fire detail and carry our own liability insurance. We will also take full responsibility in cleaning the lot prior to, and after, the event.

453 SOMEBVILLE AVE. (PARKING LOT AND OPEN HOUSE)

This is the location to which Starlab Recording Co. has been relocated. Here we plan to host the Film, Comedy and Flea Market portion of the event. The Flea Market will take place in our parking lot and we will show short films from local filmmakers in the studio. This will be a much quieter part of the festival, as to not bother our neighbors, and we will shut the doors around 6pm. Alcohol will not

be served at this location.

WALKING ROUTE

As the two locations are a short .6 mile walk apart. straight through Union Square, we think this is a great opportunity to encourage show-goers to enjoy a walk through the square and patronize the many local businesses along the way.
