The Metro Mayors Shannon Grant Community Safety Initiative (CSI) is a regional collaborative partnership that is fostered by the Metro Mayors Coalition, a group of 15 mayors and municipal managers from cities and towns in the inner core of Metro Boston. The Metro Mayors Coalition was established in 2001 and has become an effective way for communities to develop strategies and successfully advocate for policies that address shared challenges that cross municipal boundaries.
