APPROVAL CONDITION KTR 230516: Plans titled "revised plan 1 5190071.pdf", "revised plan 2 5190071.pdf", and revised plan 3 5190071.pdf are approved for the purpose of this Grant of Location with the following conditions. All conditions must be met herein prior to construction.

APPROVAL CONDITION KTR 230516: Engineering provided design feedback on May 16, 2023 that must be implemented in an updated drawing set. Eversource must provide this updated drawing set prior to issuance of Street Occupancy w/ Trench Permit for construction. The updated drawing set must show the updated proposed conduit layout, as well as the future curbing, water main, and force main locations that will be installed by the City's contractor as part of the Poplar Street Pump Station and Force Main Project. CAD drawings for the Poplar Street Pump Station and Force Main Project were shared in an email from Kevin Roche (COS Engineering) to Matt Veins (Eversource) on May 16, 2023. APPROVAL CONDITION KTR 230516: Eversource must provide as-built drawings with swing ties

and/or northing/easting coordinates within 30 days of completing conduit installation on Poplar and Linwood, separately.

APPROVAL CONDITION: MD20230227: Contractor shall take all necessary precautions to avoid damaging any tree or tree part with equipment.

APPROVAL CONDITION: MD20230227: All nearby street tree(s) shall be protected prior to and during all construction activities using TREE BOX or TREE WRAPS. . TREE BOX shall be constructed from 2 in. x 4 in. lumber creating a box around the border of the tree pit with 2 in. x 4 in. lumber standing straight up at the corners and wrapped with orange snow fence. Detail attached. . TREE WRAPS (TREE TRUNK WRAPPING PROTECTION LUMBER) shall consist of 2 in. x 4 in. and 8 ft. height lumber wired together in close spacing with zip ties or 16 gauge galvanized steel wire to form a protective enclosure around tree trunks. Use burlap to separate the wood from the bark if necessary to prevent wood from scraping or bruising bark. Do not use staples or puncture the trunk in any way. APPROVAL CONDITION: MD20230227: Any tree roots less than two (2) inches in diameter that cannot be avoided during construction shall be carefully and cleanly cut with a clean pair of pruning shears or loppers. Roots are to be cut back flush with the edge of the trench. If any tree roots greater than two (2) inches in diameter are encountered, stop work immediately and contact the City Urban Forester. Any and all pruning of roots greater than 2 inches in diameter must be completed under the supervision of the City Urban Forester.






