195477 - Requesting approval of amendments to Chapter 11 of the Code of Ordinances to establish a Mandatory Recycling Ordinance.:

Mr. Lutes and representative from the law office reviewed ongoing changes to the ordinance. On page 3 of the draft ordinance, it was approved to remove the wording "or causes to be collected" from the first paragraph. Alderman Connolly asked that the Mayor's Office inform the committee, in writing, as to how it will enforce the particulars of the ordinance.

Committee Meeting April 22, 2014

195725 - That the City Solicitor provide this Board's Committee on Legislative Matters with input on restricting formula businesses in Somerville by requiring specific review and oversight before they may enter central business districts.:

Mr. O'Donnell and Mr. Grossfield discussed how other communities have banned formula businesses and they will provide examples of the approaches used and also provide a draft template for the committee to review relating to how other communities handle this subject.
