1. Approval of the January 29, 2015 Minutes

196786: That the Director of Traffic and Parking reassess the timing of traffic lights on McGrath Highway, near Assembly Square, under the overpass heading toward Broadway, and at the intersection of Mount Vernon Street at Broadway.

The Traffic and Parking Department has hired a consultant to find improvements for this area.
