AMENDMENT NUMBER 3 *KLD 12/3/2015*

This Amendment, amends the subcontract dated November 26, 2013 under The Kresge Foundation, ("Sponsor"), for the research program titled, "Improving the Health of Near-Highway Communities" The subcontract is hereby amended by incorporating the following articles:

1. PERIOD OF PERFORMANCE

The period of performance is extended from **June 1, 2015** to **May 31, 2016**. This Agreement shall not extend beyond May 31, 2016 unless the period is extended by mutual written modification to this Agreement or terminated in accordance with the terms of this Agreement.

2. STATEMENT OF WORK

Subcontractor shall provide all necessary qualified personnel, materials and facilities to conduct the work as stated in the attached Appendix A-2, Statement of Work.

3. FISCAL CONSIDERATIONS

3.1. Allowable Costs. Allowable costs authorized under this Agreement are **\$27,645**, in accordance with the attached Appendix B-2. This includes carry forward from the previous period of \$19,221.35. Tufts agrees to reimburse Subcontractor for actual expenses incurred of this Agreement up to \$27,645, including applicable indirect costs, for the performance period of June 1, 2015 to May 31, 2016. Tufts assumes no obligation to reimburse costs in excess of this amount. No costs incurred prior or subsequent to the period of performance of this Agreement shall be allowable unless approved in writing by Tufts' Authorized official.

All other terms and conditions remain the same.




