Dear Board Members:

Preliminary approval is recommended for the petition and plan of NextG Networks to install aerial fiber optic cable to existing utility poles along Vernon Street beginning near Lowell Street at Pole 12 and continuing southeasterly to Bartlett Street, running northerly along Bartlett Street to Robinson Street, thence southeasterly on Robinson Street to Pole 299-4. Permission is also granted to install optical repeater telephone equipment and a pole top antenna at existing wood utility pole 299-4 on Robinson Street

This recommendation is made with reference to NextG's letter of December 14, 2010 and plan of December 14, 2010 upon stipulation that the Grant of Location is subject to: a reservation of rescission by the Board of Aldermen; indemnification of the City for all liability arising from said Grant; all permit procedures, conditions and approvals of municipal utilities; protection of existing infrastructure; and complete surface repair, restoration and maintenance. A public hearing will be required.

This work is necessary to expand Next G's existing telecommunications infrastructure within Somerville, MA.

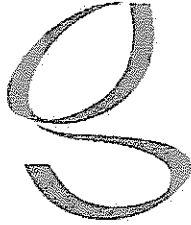


NextG respectfully requests permission for the following under this petition:



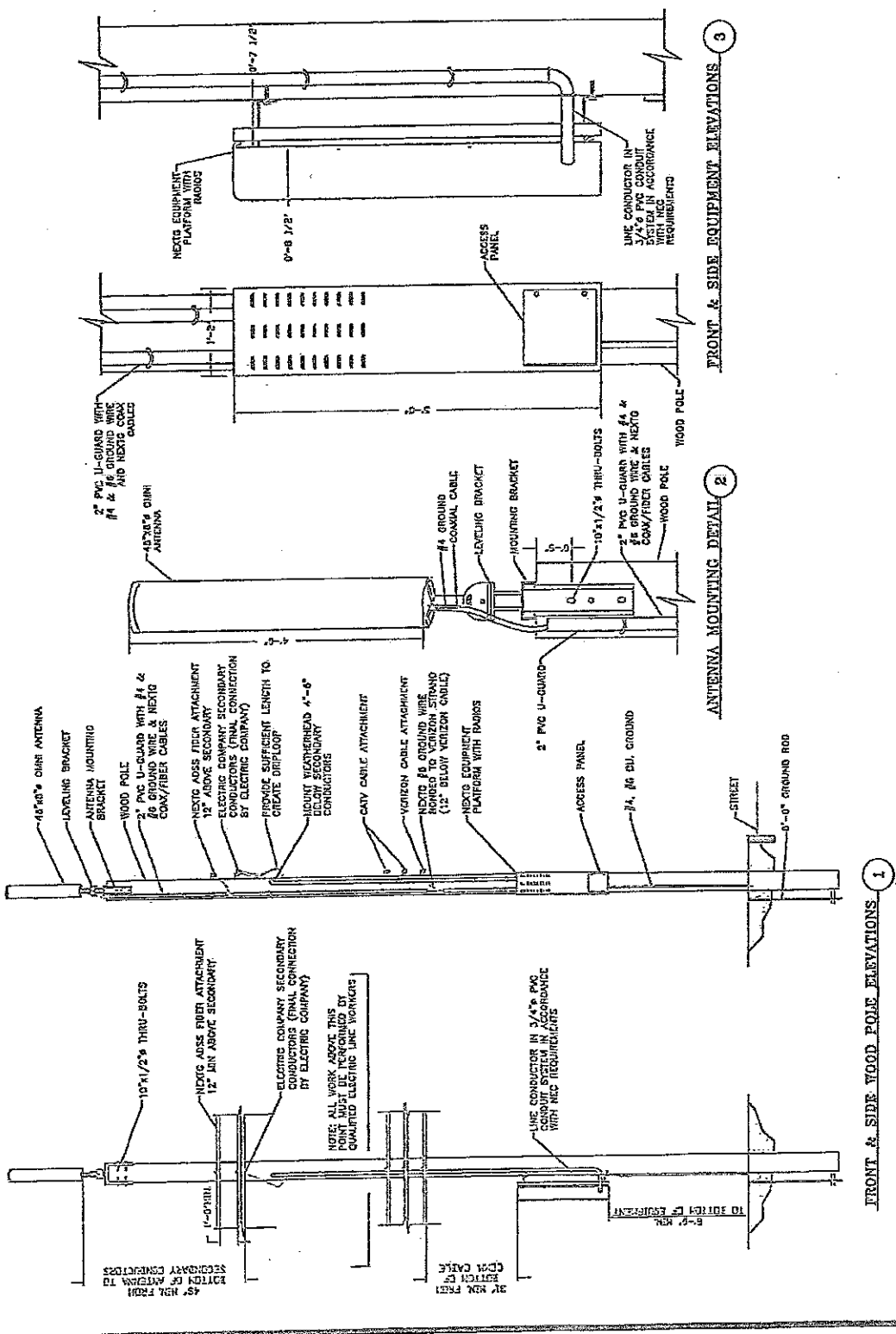
