#### REPORT OF THE COMMITTEE ON LICENSES AND PERMITS

The Committee on Licenses and Permits convened on September 26, 2007, with Chairman Bruce Desmond presiding and Committee Members Aldermen Maryann Heuston and Robert Trane also present and voting. Also present were Alderman Sean O'Donovan and William Roche as well as Paul Nonni from Inspectional Services, Bill Zamparelli and William Harris from NSTAR, Attorney Richard DiGirolamo, representatives from ATO Associates and interested members of the public.

Public Hearing: Pearl Street Auto Sales, 56 Bonair St., Garage License Attorney DiGirolamo asked that the matter be held in committee for the time being. Chairman Desmond said that the committee would receive testimony but would postpone rendering a decision on the matter. Alderman Roche informed the members that the business has moved into the location and is operating without a permit. He said that he has received numerous calls from neighbors who are against issuing the permit and also stated that he disagrees with the use of the building, since it hasn't been used for 2 years. Mr. Steve Matarano told the members that the owner is using the garage to wash cars and perform other work without a permit. Attorney DiGirolamo stated that the owner's scale of operation is to detail 2-3 vehicles per day, for dealers only, not for the general public. Alderman Roche said, that because of errors on the application, it will need to be corrected and re-submitted. In the meantime, Alderman Roche will hold a neighborhood meeting to attempt to work out a plan that would accommodate all parties involved. A copy of a 1988 decision by the Board of Appeals was introduced and Alderman Trane made a motion that the City Solicitor research the June 10, 1988 decision by the Board of Appeals, (#1988-31), regarding the property at 56 Bonair Street, and report back to the Committee on Licenses and Permits and to the attorney representing the applicant, (Pearl Street Auto Sales), with an opinion regarding the legality of the decision. The motion was approved.

Chairman Desmond continued the hearing until the Solicitor renders the requested opinion and until Alderman Roche's neighborhood meeting on the matter is held.

Mr. Harris told the members that locations for tree trimming are called in to the DPW on a daily basis and that approximately 75% of the trees on Hudson and Albion Streets have already been taken care of. As to the problems experienced, Mr. Harris said that he would visit the property owners involved and that the tree trimming crews have been informed to stop the work if a resident becomes upset. Mr. Harris said that he did look at the trees on Hudson Street and, in his opinion, there wasn't a major problem with them.

Alderman Trane's motion that Mr. Harris meet with the Ward 5 Alderman to visit property on Albion Street and to speak to the residents regarding the problems experienced with the pruning of trees, was approved.

Alderman Heuston's motion that the City's Tree Warden notify the Communication Department of tree trimming to be performed AND BE IT FURTHER ORDERED That the Director of Communication utilize the Connect CTY system to notify residents in the area of the work to be performed and include the Ward Alderman in the notification list, was approved.

**Prospect Iron and Steel** 

The committee is waiting for clarification of the legal address of the property and what types of work may be performed at the facility. Additionally, the committee requested that the Legal Department inform the committee of any past legal decisions involving the property. Alderman Heuston asked that the zoning issues be clarified, as well. Attorney DiGirolamo told the members that there has been banging in the building but that his clients are working on a remedy to the problem. Additionally, Attorney DiGirolamo said that his client would like to operate on Saturdays.

#### ATO - Tufts

Alderman Trane reported that he has received complaints from neighbors regarding the behavior of the residents of property operated by ATO. Representatives from ATO told the members that they have not received any formal complaints from either the Somerville or Tufts Police. Chairman Desmond made it clear that ATO is not in good standing with the city and he is concerned by the lack of remorse from the fraternity members residing at the property.

Alderman Heuston's motion that the Director of Strategic Planning and Community Development, along with the Chief Fire Engineer, notify the occupants of the property at 134 Professors Row that the fire escape is to be used for emergency purposes only, and that it is not to be used as a deck for parties, was approved. Alderman Heuston also said that Tufts needs to keep their community clean and that ATO needs to post signs on the fire escape notifying occupants that it is to be used for emergency purposes, only.

Alderman Trane said that he has notified Barbara Rubel at Tufts of the problem and he also said that police in an unmarked car would patrol the area and that anyone found to be breaking the law would be arrested, in keeping with the city's zero tolerance policy.

Mr. Nonni suggested that ATO require all house members to sign a document notifying them that notice is hereby served that the fire escape is to be used in an emergency, only
