**ORDER OF TAKING**

**WHEREAS**, the Board of Aldermen of the City of Somerville, acting on behalf and in the name of the City of Somerville, hereby declare that the public necessity and convenience require the property described below and any and all property rights therein, to be taken by Eminent Domain for a public purpose, namely for all purposes for which public ways are used.

**WHEREAS**, all preliminary requirements prescribed by law having been met as required under Massachusetts General Laws c. 79, §1;

**NOW THEREFORE BE IT ORDERED** the City of Somerville acting pursuant to the applicable provisions of Massachusetts General Laws, Chapter 79, as amended, and any and every power and authority to it, granted or implied, by virtue of and in accordance with the authority of the provisions of Chapter 79 of the General Laws, as amended, and any and every other power and authority that is hereunto in any way enabling, hereby takes, for all purposes for which public ways are used, including, without limitation, constructing, improving, repairing, relocating, realigning and/or reconstructing Beacon Street, including the construction of new sidewalks, curbing, asphalt paving, re-grading of driveways and/or walkways and intersection improvements along Beacon Street from Roseland Street to the Cambridge Line in Somerville, Massachusetts (the “Project”), all as shown on a plan of land entitled \_\_\_\_\_, dated \_\_\_\_\_, and on file with the Somerville City Clerk, City Hall, 93 Highland Avenue, Somerville, MA 02143, with a copy on file with the City of Somerville Engineering Department, 1 Franey Road, Somerville, MA 02145 (“Plan”). Permanent easements necessary for the Project are as shown on a plan of land entitled, “\_\_\_\_\_” dated \_\_\_\_\_, recorded with the Middlesex South Registry of Deeds in Plan Book \_\_\_\_, Plan \_\_\_\_\_ (“Permanent Easement Plan”).

1. Permanent easements in, on, over, under and along the parcels of land shown on the Permanent Easement Plan as SW-1 and SW-2 (collectively, the “Permanent Easement Premises”) for all purposes for which public ways are used in the City of Somerville and for all uses necessary or incidental thereto, including but not limited to, constructing, operating, improving, maintaining, repairing, replacing, relocating,

realigning, regrading, and/or reconstructing rights of way, sidewalks, slopes of excavation or embankment, retaining walls, stone walls, driveways, and/or drainage facilities and/or other utilities.

2. Temporary construction easements in, on, over, under and along the parcels of land shown on the Plan as TE-1 through TE-115 (collectively, the “Temporary Construction Easement Premises”), for the purpose of undertaking the Project and for all uses necessary or incidental thereto, including, without limitation, grading land, constructing, operating, improving, maintaining, repairing, replacing, relocating, realigning, and/or reconstructing slopes of excavation and/or embankment and/or driveway aprons, sidewalks, retaining walls, stone walls, landscaping, loaming, seeding and/or paving. Said temporary construction easements shall terminate automatically three years from the date of recording of this Order of Taking without the necessity of recording any instrument with said Registry of Deeds. Nothing in this paragraph shall affect the permanent easements acquired by the City hereunder.

The City shall have the right of entry upon and passage over the Permanent Easement Premises and the Temporary Construction Easement Premises (collectively, the “Easement Premises”) from time to time by foot and motor vehicles, including heavy equipment, for the purposes set forth herein and all uses necessary or incidental thereto. The City shall have the right to remove any structures, objects, utilities and /or vegetation (including trees and shrubs) now or hereafter located within the Easement Premises as may be necessary or convenient to exercise the easement hereby taken. Any utilities and related facilities located within the Easement Premises that are owned by private utility companies and easements held by private utility companies are not taken.

Said easement are owned or supposed to be owned and/or formerly owned by the parties listed in Exhibit A, attached hereto and incorporated herein, which parties are hereinafter collectively referred to as Owners. If in any instance the name of any Owner or Owners is not correctly stated, it is understood that in such instance the land referred to is owned by an Owner or Owners unknown to us, and the interests associated therewith are hereby taken.

**AND FURTHER ORDERED** that the City shall cause this Order of Taking to be recorded with the Middlesex South Registry of Deeds in Cambridge, MA, and shall notify the Treasurer and Collector of Taxes in the City of Somerville of the taking in accordance with M.G.L. c. 79, §7F.
