SOMERVILLE Layout No. 9008

The Massachusetts Department of Transportation, Highway Division, acting on behalf of the Department of Conservation and Recreation (formerly Metropolitan District Commission-MDC), as authorized by Chapter 25 of the Acts of 2009, does hereby alter a portion of a highway, being known as Monsignor McGrath Highway (Route 28), in the City of Somerville, County of Middlesex.

The alteration consists of revising the location line of the of Department of Conservation and Recreation Parkway of Monsignor McGrath Highway (Route 28) on the westerly side thereof and more fully described as follows:

McGrath Highway (Route 28) baseline used for this alteration begins at a point within the existing roadway of Interstate Route 93 at a point on the Auxiliary baseline B of the November 22, 1967 (Layout No. 5723) State highway alteration of Northern Expressway (Route 93), at station 115+93.46, at N 2968302.0946, E 768179.5842, shown on the plan hereinafter referred to as station 0+00.00 and extends thence S 36°59'17" W 1,332.20 feet to the point of ending thereof, at N 2967237.9827, E 767378.0633, shown on the plan hereinafter referred to as station 13+32.20.

The stations hereinafter referred to are points thereon. The Coordinate system used is the Massachusetts Coordinate System North American Datum of 1983 (NAD 83).

The location of highway hereby altered and laid out begins at a point on the location line of the Metropolitan District Commission as of July 21, 1949 of Monsignor McGrath Highway (Route 28) on the northerly side thereof and the southerly location line of November 22, 1967 (Layout No. 5723) State highway alteration of Northern Expressway (Route 93), at N 2968312.4833, E 768136.0657, said point bearing N 30°04'20" W and being 44.53 feet distant from station 0+35.24 of the McGrath Highway baseline, hereinbefore described and extends thence, following the southerly location line of November 22, 1967 (Layout No. 5723) State highway alteration, N 30°04'20" W 115.37 feet to a point at N 2968412.3257, E 768078.2538; thence N 31°00'00" W 59.48 feet to a point at N 2968463.3100, E 768047.6193; thence N 86°43'41" E 63.12 feet to a Massachusetts highway bound on the southerly location of November 22, 1967 (Layout No. 5723) State highway alteration of Northern Expressway (Route 93), at N 2968466.8971, E 767984.6156; thence, leaving said location lines southwesterly by a curve to the right 1,007.00 feet radius 576.94 feet a chord bearing S 19°41'05" W and a chord distance of 569.08 feet to a point at N 2967931.0892, E 767792.9100; thence S 36°59'17" W 586.53 feet to a point at N 2967462.5905, E 767440.0228; thence southerly by a curve to the right 50.00 feet radius 77.27 feet a chord bearing N 81°15'43" E and a chord distance of 69.81 feet to a point at N 2967451.9682, E 767371.0482; thence S 25°31'51" W 170.09 feet to the point of ending thereof, on the southwesterly end of location line of the Metropolitan District Commission as of July 21, 1949 of Monsignor McGrath Highway (Route 28), at N 2967298.4854, E 767297.7392, said point bearing N 53°00'43" W and being 100.56 feet distant from station 13+32.20 of said baseline.

The location line of the Department of Conservation and Recreation Parkway hereby altered and laid out as hereinbefore described is to be further defined by bounds set thereon at the angle points, points of curvature, and at the points beginning and ending thereof, where feasible.

The location line of said highway, as hereby altered and laid out is shown on a plan signed by the Chief Engineer, and signed by the Massachusetts Department of Transportation, Highway Division and on file in its office, said plan being entitled:
