The Unaccompanied Homeless Youth Commission was established in 2012 and has been working since to outline a strategy for better understanding the scope and needs of unaccompanied homeless youth. Fortunately this year the state's budget includes resources to enhance the work of the Commission. As a result, I am pleased to inform you that the Department of Housing and Community Development will make a grant of \$5,000 available to the Somerville (MA-517) CoC in order to support efforts to conduct a count and survey of unaccompanied homeless youth during this year's Point In Time count..

Participation by the Somerville (MA-517) CoC will be important for our statewide goal of obtaining improved statewide data that will inform policy and program design. With a clearer understanding of this vulnerable population, we will be better positioned to allocate resources in a more effective manner, with the ultimate goal of ending homelessness among youth.
