Preliminary approval is recommended for the petition and plan of NSTAR Electric Company d/b/a Eversource to install approximately 49 feet of (1) 3 inch PVC conduit from utility pole 195/4 to 88 Dover Street. The conduit will be laid in Dover Street. Dover Street is a public way in Somerville, MA.


