10/10 – Present -Fire Fighter: Duties include but are not limited to fire suppression in structural as well as wild land environments and emergency medical services under highly stressful emergency conditions. Also, fire prevention, public education, vehicle and station maintenance under the supervision of a Captain, always focusing on providing quality customer service. Training includes: High angle rescue, confined space rescue, trench rescue, building construction for the fire service.

7/09 – 9/10 U.S Army Company Commander: Commander of a Basic Combat Training Company responsible for the health, welfare, and training of 240 Soldiers in Training per cycle, 24 Cadre members, and 2 Civilians. Principally responsible for all actions occurring within the company. Responsible for developing tactically and technically proficient Soldiers capable of performing full spectrum Army operations immediately upon entering the force. Responsible for the maintenance and security of four vehicles, 242 weapons, and assigned equipment worth over \$3.5 million. Directly responsible for planning, resourcing executing, supervising, and evaluating training.
