Bounded on the west by the Arlington town line.

Somerville - Ward One

Bounded to the north by the Everett/Medford city line; bounded to the east by the Somerville/Boston city line; bounded to the south by the Somerville/Cambridge city line; bounded to the west by the Fellsway from the Everett/Medford city line to Mystic Ave, turning northwest on Mystic Ave to Fellsway West, turning south on Fellsway West to Broadway, turning northwest onto Broadway to Walnut St, turning south on Walnut St to Pearl St, turning west on Pearl St to Medford St, turning southeast on Medford St to the MBTA commuter rail tracks, running southeast on the MBTA commuter rail tracks to Walnut St, turning south onto Walnut St to Medford St, running southeast on Medford St to McGrath Hwy, running southeast on McGrath Hwy to Washington St, turning east onto Washington St to MBTA commuter rail tracks; running southeast along the MBTA commuter rail tracks to the Somerville/Cambridge city line.

Somerville - Ward Two

Bounded to the north by Somerville Ave, at the Cambridge city line, traveling southeast to Elm St., continuing southeast along Somerville Ave to Beech St, turning north onto Beech St to Atherton St, turning southeast onto Atherton St to Central St, turning northeast onto Central St to Summer St, traveling southeast onto Summer St to Church St, turning south onto Church St to Somerville Ave, turning southeast onto Somerville Ave to Washington St extended westerly, traveling east on Washington St and its extension to the MBTA commuter rail tracks, turning southeast onto the MBTA commuter rail tracks to the Cambridge city line, bounded to the south and the west by the Cambridge city line.



Somerville - Ward Three

Bounded to the north by Highland Ave, from Porter St running southeast to Central St, turning northeast onto Central St to the MBTA commuter rail tracks, turning southeast onto the MBTA commuter rail tracks to Sycamore St, turning northeast onto Sycamore St to Richdale Ave, running southeast on Richdale Ave to School St, running northeast on School St to Medford St, turning southeast onto Medford St to the MBTA commuter rail tracks, turning southeast on the MBTA commuter rail tracks to Walnut St, turning south onto Walnut St to Medford St, turning southeast onto Medford St continuing southeast on Medford St to McGrath Hwy, turning west onto Washington St, traveling west on Washington St and its extension to Somerville Ave, running northwest on Somerville Ave to Church St, turning northeast onto Church St to Summer St, turning northwest onto Summer St to Central St, turning southwest onto Central St to Atherton St, turning northwest onto Atherton St to Beech St, turning southwest onto Beech St to Somerville Ave, turning northwest onto Somerville Ave to Elm St, running northwest on Elm St to Porter St, turning northeast onto Porter St to Highland Ave.

Bounded to the north by the Somerville/Medford city line; bounded to the west by the Somerville/Medford city line to Main St. Bounded to the east by the by the Fellsway from the Everett/Medford city line to Mystic Ave, turning northwest on Mystic Ave to Fellsway West, turning south on Fellsway West to Broadway, turning northwest onto Broadway to Walnut St, turning southwest onto Walnut St to Pearl St. Bounded to the south by Pearl St to Medford St; traveling on Medford St to School St; turning south onto School St to Richdale Ave; turning northwest onto Richdale Ave to Sycamore St; turning northeast onto Sycamore St to Pembroke St, turning northwest onto Pembroke St to Tennyson St, turning northeast onto Tennyson St to Forster St; turning northwest onto Forster St to Central St; turning northwest onto Central St to Broadway; turning southeast onto Broadway to Main St; turning northwest onto Main St to the Somerville/Medford city line; bounded to the west by the Somerville/Medford city line.

Somerville - Ward Five

Bounded to the north by the Somerville/Medford city line at Packard Ave, running southeast to Boston Ave, turning south onto Boston Ave to Broadway, turning northwest onto Broadway to Josephine Ave, turning southwest onto Josephine Ave to Morrison Ave, turning southeast onto Morrison Ave to Highland Rd, turning southwest onto Highland Rd, running in a straight line to Spencer Ave, turning southeast onto Spencer Ave to Cedar St, turning southwest onto Cedar St to Highland Ave, turning northwest on Highland Ave to Cherry St, turning southwest onto Cherry St to Elm St, turning northwest onto Elm St to Russell St, at City boundary no.17, turning southwest on Russell St to the Somerville/Cambridge city line at City boundary no. 19, turning northwest along the Somerville/Cambridge city line to Kingston St, turning east onto Kingston St to Thorndike St, turning northeast on Thorndike St and its extension to Holland St, turning northwest onto Holland St to Simpson Ave, turning northeast onto Simpson Ave to Broadway, turning southeast onto Broadway to Burnham St, turning northeast onto Burnham St to Powder House Blvd, turning northwest onto Powder House Blvd to Packard Ave, turning northeast onto Packard Ave to the Somerville/Medford city line.

Somerville - Ward Seven

Bounded to the north by the Somerville/Medford city line at Packard Ave, turning southwest onto Packard Ave to Powder House Blvd, turning southeast onto Powder House Blvd to Burnham St, turning southwest onto Burnham St to Broadway, turning northwest on Broadway to Simpson Ave, turning southwest onto Simpson Ave to Holland St, turning southeast onto Holland St to Thorndike St, turning southwest onto Thorndike St and its extension to Kingston St, turning west on Kingston St to the Somerville/Cambridge city line; bounded to the south by the Somerville/Cambridge city line; bounded to the west by Somerville/Arlington town line.

Somerville - Ward One, Precinct One

Bounded to the north by Pearl St at Cross St, , running southeast to Glen St, turning northeast onto Glen St to Webster St, turning southeast onto Webster St to Franklin St, turning south onto Franklin St to Pearl St, turning southeast onto Pearl St to Mt Vernon St, turning northeast onto Mt Vernon St to Perkins St, turning east onto Perkins St to the Somerville/Boston city line, bounded to the east by the Somerville/Boston city line, bounded to the south by the Somerville/Cambridge city line, traveling west to the MBTA commuter rail tracks, running northwest along the MBTA commuter rail tracks to Washington St, turning southwest onto Washington St to McGrath Hwy, turning northwest onto McGrath Hwy to the MBTA commuter rail tracks, turning southeast onto the MBTA commuter rail tracks to the extension of Avon Pl, turning east onto Avon Pl and its extension to Cross St, turning northeast onto Cross St to Pearl St.

Somerville - Ward One Precinct Two

Bounded to the north by the Somerville/Medford/Everett city lines, bounded to the east by the Somerville/Boston city line, bounded to the south by Perkins St, starting at Somerville/Boston city line running northwest to Mt Vernon St, turning southwest onto Mt Vernon St to Pearl St, turning northwest onto Pearl St to Franklin St, turning northeast onto Franklin St to Webster St, turning northwest onto Webster St to Glen St, turning southwest onto Glen St to Pearl St, turning northwest onto Pearl St to Cross St, turning northeast onto Cross St to Broadway, turning northwest onto Broadway to Fellsway West, turning northeast onto Fellsway West to Mystic Ave, turning southeast onto Mystic Ave to Fellsway, turning north onto Fellsway to Somerville/Medford city line.

Bounded on the north by Broadway from Walnut St to Cross St. Bounded to the east by Cross St from Broadway to Avon Pl; bounded to the south by Avon Pl and its extension from Cross St to the MBTA commuter rail tracks to McGrath Hwy, turning south onto McGrath Hwy to Medford St, turning northwest onto Medford St to Walnut St, turning north onto Walnut St to the MBTA commuter rail tracks, traveling west along the MBTA commuter rail tracks to Medford St, traveling northwest onto Medford St to Pearl St, turning southeast onto Pearl St to Walnut St; turning northeast onto Walnut St to Broadway.

Somerville - Ward Two Precinct One

Bounded to the north by Knapp St, running southeast to School St, turning northeast onto School St to Summer St, turning southeast onto Summer St to Church St, turning southwest onto Church St to Somerville Ave, turning southeast onto Somerville Ave to Washington St extended westerly, turning east onto Washington St and its extension to the MBTA commuter rail tracks, turning southeast onto the MBTA commuter rail tracks to the Somerville/Cambridge city line, running west along the Somerville/Cambridge city line to Oak St, turning north onto Oak St to Houghton St, turning northwest on Houghton St to Springfield St, turning northeast on Springfield St to Concord Ave, turning east onto Concord Ave to Oak St Place extended northerly, turning south onto Oak St Place and its extension, continuing south on Oak St Place to Oak St, turning northeast on Oak St to Prospect St, turning northeast on Prospect St to Webster Ave, turning north onto Webster Ave to the MBTA commuter rail tracks, running northwest along the MBTA commuter rail tracks to Dane St, turning northeast onto Dane St to Somerville Ave, traveling northeast along Granite St to Knapp St.

Somerville - Ward Two Precinct Two

Bounded to the north by the MBTA commuter rail tracks from Webster Ave to the northerly extension of Hodgdon Place, south onto Hodgdon Pl and its extension to Dane Ave, east onto Dane Ave to Leland St, south onto Leland St to Washington St, west onto Washington St to the Somerville/Cambridge city line; bounded on the south by the Somerville/Cambridge city line. Bounded on the east by Oak St from the Somerville/Cambridge city line to Houghton St, turning northwest on Houghton St to Springfield St, turning northeast on Springfield St to Concord Av, turning east on Concord Ave to Oak St Place extended northerly, turning south onto Oak St Place and its extension, continuing south on Oak St Place to Oak St, turning northeast on Oak St to Prospect St, turning northeast on Prospect St toWebster Ave, running north on Webster Ave to the MBTA commuter rail tracks.

Somerville - Ward Two Precinct Three
