OPENAIR Circus - license requests for July 28-August 3

Dear John,

I just spoke with Jill about the license requests for July 28-August 3 that I submitted. She has informed me that Conway Field is not available for July 31. As such, we'll need to move the OPENAIR Circus performances to Nunziato field. As part of this shift in the plan, we'll also be hold our dress-rehearsal (July 30) at Nunziato and setting up the tent that morning. We'd like to keep the rehearsals on July 28 and 29 at Hodgkins to minimize the impact on the community around Nunziato. Below is a summary of our new plans (let me know if I should just go in and document by editing the license requests):

## Related to License # PEL15-000071

Remove July 30, the rehearsals covered by this request will only be July

28 and 29. Both will be at Hodgkins and will remain as setup starting at 4pm, rehearsal itself occurring from 4:30pm to 8:30pm, and cleanup ending at 9pm

### Related to license # PEL15-000068

Change location to Nunziato Field

Add July 30: we'll now have the tent delivered to Nunziato on Thursday morning.

Setup will begin first thing Thursday morning (8am; typically tent is done by 2pm, tent setup is limited to the top half of the field) with the tent arrival and additional supplies arriving throughout the day. Rehearsal itself will be from 4:30pm-9:00pm.

#### Additional details:

- -We will lock the gates at Nunziato each evening (after sundown) and unlock each morning (typically I arrive around 8am to relieve the tent sitters and they often have the gates open by the time I arrive).
- -It's fine for anybody else to use the lower half of the field all day Thursday, July 30, and any time aside from the performances and cast party (though we wouldn't ask people to leave, if anything we'd ask them to be considerate of the performance going on):

#### Performance times:

Friday July 31: 6-8:30pm

Saturday August 1: 2-4:30pm and 6-8:30pm Sunday August 2: 2-4:30pm followed by cast party that ends before 7pm Monday August 3: tent cleanup is typically finished by noon with my final walk through of the park to clean up any remaining trash typically finishing by 2pm
