Residents spoke about having to deal with flooding events, some as far back as 1986, and their experiences in having to deal with sewerage during those events. Alderman Rossetti spoke about flooding on parts of the bike path and read statements from constituents who were unable to attend this meeting.

Ms. Miguel spoke about the city's sewer lines and the planned retention tank in Union Square and the sewer separation projects in Union Square and on Cedar Street. The sewer system is being cleaned, which should help to alleviate some of the problems, and a capital improvement plan is being worked on. Ms. Miguel noted that even if the system was separated, flash flooding would continue to be a problem. Ms. Miguel told the members that it would take a few years to remedy the problems and would cost about \$5.3 billion to fix problems in the entire system.

the next 6 months. Mr. Buckley discussed the state plumbing code and when backflow preventers are required, noting that the city cannot supersede state law. Committee members expressed concern that requests for work have taken so long and discussed

Committee members expressed concern that requests for work have taken so long and discussed the de-paving of city property, citing the amount of concrete and asphalt throughout the city as a problem. The committee also discussed the "stretch code" used in Cambridge, sub-grade development in areas with a history of flooding, ways to better inform the public, and having discussions with both the Planning and Zoning Boards regarding backflow preventer requirements. Mr. Smiljic will review the plumbing code, and its interpretation, and report back to the committee.
