

The general set-up/locations are as follows:

1. Broadway, Cedar St. to Medford St.

- a. When the crews are filming inside the Tavern, No Parking will be posted between Trum Field and Broadway to allow for work trucks.
- b. All departments recommended that we plan for the closure of the sidewalk in front of the Tavern in case there are large crowds gathering there to try to get a glimpse of the actors.
- c. There will be at least 3 police officers and 1 supervisor, to deal both with potential crowds and to assist with safe vehicle and pedestrian travel in the area. Though we don't anticipate any lane diversions, etc., rubbernecking and slowed traffic will be natural with this kind of event throughout the day.

Medford St.

a. On the night of July 1, the crew will film a scene on Medford St. The exact details of the closure are being developed by T&P and SPD.

3. Dilboy Stadium Parking Lot

a. Base camp. This is where the actors' trailers will be stationed. There will be private security there, and it will have little to no impact on the community nor on any teams utilizing Dilboy for practice. Jill Lathan has contacted those teams and asked them to park behind the pool; they will still be able to utilize the drop-off section in front of the stadium as well for drop-off and pick-up.

4. Trum Field Basketball Courts

a. Catering. Using only the courts, not the field, the company will set up tents for crew/actor catering. It will not impact any planned programs or events.

5. Tufts University Parking Garage

a. Crew parking. They'll be shuttled back and forth from Boston Ave. to Magoun Sq.

Hi Alderman Niedergang,

I wanted to follow up on my email from a few weeks ago regarding the planned filming in Magoun Sq. at the end of June. We met as a group on Thursday and it was a very productive discussion with each department feeling confident in the ability to plan and execute this with little to no issues or concerns. Below, I've summarized what the company is seeking to do as well as the takeaways and to-dos for each involved department. Beyond this, please let me know if you have additional questions and I'm happy to answer them. I'm also going to send this to Dennis (as chair of L&P) and Katjana (there is some off-street parking at Dilboy).

"Central Intelligence," starring Dwayne Johnson and Kevin Hart, is a Warner Bros. film that will be in Magoun Sq. June 29-July 1. For the first two days, they'll be filming inside of On The Hill Tavern, and on the night of July 1, they'll close Medford St. for an outdoor scene between Lowell St. and Broadway. (No Parking signs would be posted for noon in three spots opposite Magoun Saloon, and other spots in that stretch posted for 5 p.m.; the road would close at approx. 8 p.m. The Film Scouts have already been around to many businesses on the street and are continuing their outreach as we speak. Once a TMP for the proposed closure is identified by T&P, we will notify residents in a wider section. I'll keep you posted about that as well.)

There are 3-4 generators that will be placed in various locations. Most of them will be placed in private driveways (with permission) so as not to cause inconveniences to residents or businesses. These details are currently being worked out by the film scouts, T&P, DPW, and SPD. When final, we will share the maps.

The general set-up/locations are as follows:

- c. There will be at least 3 police officers and 1 supervisor, to deal both with potential crowds and to assist with safe vehicle and pedestrian travel in the area. Though we don't anticipate any lane diversions, etc., rubbernecking and slowed traffic will be natural with this kind of event throughout the day.
