



I have reviewed the Public Event Application for the Somerville Homeless Coalition Road Race scheduled for October 3, 2013. This will be the eighteenth annual race and SHC will be hiring 1 detail officer in addition to using the Somerville Auxiliary Police Department for traffic and pedestrian control. Last year's race was the first year the race organizers have used the MBTA access road for both the start and finish of the race. This new start and finish location cuts road closures to a minimum. I recommend that the permit be approved as requested.
