About ARPA

- \$77.5M for COVID recovery projects
 - Public health
 - Combatting the negative economic impacts of the pandemic
 - Serving the hardest-hit communities
 - Premium pay for essential workers, prioritizing low-income workers, capped rate \$13 per hour
 - Revenue loss for municipal government
 - Water, sewer, and broadband infrastructure
- Funds must be obligated by the end of calendar year
 2024 and spend by the end of calendar year
 - Funds cannot be reallocated to different projects after 2024, so projects using the 2026 deadline should have a fixed budget

ARPA Funding Process

- Applicants (City departments and community-based organizations) meet with the ARPA team to ensure their proposal meets the ARPA funding guidelines
- Applicants submit their proposal via online portal
- Proposal reviewed by ARPA team and consultants, with edits requested as necessary
- Proposal sent to the Mayor for final approval
- Applicant notified and work begins

- Emergency management staff
- Rapid testing for hardest-hit communities
- Hand sanitizer in parks
- Contact tracing and workplace COVID safety measures

- Childcare tuition assistance program (\$6.1M)

Basic Needs

- Housing: rental assistance (\$1M), legal services, and emergency hotel
- o Food: cab to food and medical program, Just Eats boxes for SHA
- Universal Basic Income (in process) (\$2M)

- ARPA office staff to manage application process
- o Translation, interpretation, and printing costs for community outreach





ARPA Survey Demographics




ARPA Survey Demographics
