A consulting group is currently working on a study to address this issue and Mr. Boukili informed the members that it should be completed by the beginning of the year. There was also a discussion regarding mutual aid among communities.

Alderman Connolly's motion that Matrix Consulting appear before the Public Health and Public Safety Committee, upon completion of their study, to report their findings regarding the status of the city's public safety, was approved.
