• requested that the Administration send a communication to the Board of Aldermen regarding the status of a replacement facility in the Fire Department.

• requested (from Chief Kelleher) a breakdown of line item #519013 - Other Lump Sum Payments.

Ald. White:

- requested (from Chief Pasquarello) that additional information be provided, including the effect of the Quinn Bill, regarding line item #511000 Salaries, to account for the \$1.3 million not yet encumbered.
- requested (from Chief Pasquarello) information, in graph form, of the Police Department's overtime expenditures for FY-11.
- requested (from Chief Pasquarello) a report on the amount of money realized from the forfeiture program in FY-11 and the amount expected for FY-12.
- requested (from Chief Pasquarello) an explanation of the amount of money spent for court time.
- Requested (from Mr. Bean) additional information for the Communications Department Revolving Fund.
