Boston Walk with Us to Cure Lupus Walk Directions

- 1. Walk leaves from the grassy area at 330 Great River Road
- 2. Follow the walking path along Grand Union Boulevard, curving to the right, parallel to Fellsway (Rt. 28), on the underground footbridge.
- 3. Continue on the sidewalk on Shore Drive, following the curve of the Mystic, passing the Blessing of the Bay Boathouse.
- 4. Now on the path parallel to the Northern Expressway, continue on the walking path until it divides near Mystic Valley Parkway (Rt. 16).
- 5. Turn right onto the bridge, staying on the sidewalk, cross the bridge to the walking path.
- 6. Following the walking path parallel to the Mystic Valley Parkway (Rt. 16), turning right at the Medford State Police Station.
- 7. Follow the walking path that's parallel to the Fellsway (Rt. 28) backing walk to DCR's Baxter Park.
- 8. Turn left, and head back to the starting point.
