"Paint is not protection." Every day I commute less than 3 miles across Somerville from East to West. It's not even the full width of our fair city. The only truly "protected" areas of this trip are the \sim 10' in Porter that's a sidewalk extension (but is still very dangerous, we can discuss this another time) and the \sim 10' in Union Sq that is currently bikes only due to construction and is protected by chainlink fences.

The rest of the 2.7 miles, I'm in painted bike lanes dodging uber drivers, unmarked amazon deliver vans, city buses, and everyone who puts their hazard lights on (or doesn't) because "it'll only be a minute and they need to put there care *somewhere*." I don't have pictures or videos of these 5-10 vehicles I see *each way every day* because I'm busy trying to stay alive.

I am a Somerville resident and voter. I live at 140 Summer St. I am also a year-round bicyclist who bikes everywhere in the city. And I'm someone who was hit by a car just a little less than a year ago, and I'm still getting over the effects of the concussion I got from that accident.

I am writing to say how strongly I support the proposal for a 2-way protected bike path on Powder House Boulevard. I already ride on Powder House and find it very dangerous. Obviously adding some paint for a bike line would be nice. But bike lanes, as I found out in my own accident, and as I believe the statistics show, really don't offer much if any protection. You're still at risk of moving cars turning into you and parked cars opening their doors.

The only real safety for a cyclist, I know from continual personal experience, is a truly separate bike lane. And adding such a lane on Powder House will make a huge difference for the bike infrastructure in Somerville. I hope you will implement what is the only truly safe option. I have a new helmet, but I worry every day what getting hit by another car would do to me. With a protected bike lane, I know that I'll be safe.

As dedicated bicyclists commuting to work, errands and pleasure, and the parents of a budding 8 year-old cyclist, we value any work the city does to make biking safer. We appreciate the new paint lanes and sharrows, and certain one-way streets allowing biking in both directions. But protected bike lanes are the best.

We choose biking over driving as often as we can because we know it helps reduce traffic congestion and pollution. Ben is lucky enough to commute daily on the Minuteman path. On many roads in Somerville, we find it incredibly stressful to bike in a painted lane between rushing traffic and parked cars, whose doors can open at any moment. When biking with our son, we bike on sidewalks (where allowed) because the roads are not safe for a learning cyclist (and often not safe for experienced ones). When biking on Powder House Blvd to the West Somerville Neighborhood School we often choose sidewalks because we just don't feel safe.

A 2-way protected bike lane is our preferred design. As more people choose cycling because it is safer, and perhaps get rid of a car as we did, there will be less need for parking.
