- 1. Approval of the April 15, 2021 Minutes
- **2. 210235: Discuss** (Mbah, Scott, Davis, Ewen-Campen, Strezo, Rossetti, Ballantyne, Clingan, White Jr.) Calling upon this Council to create a Police Commission and a Community Police Review Agency.
- **3. 211601: Discuss** (McLaughlin, Clingan, Ballantyne, Davis, Scott, Strezo, Mbah) That the City Solicitor and the Chief of Police discuss with the Committee on Legislative Matters a formal policy or ordinance to decriminalize or deprioritize arrests for drug possession, and prioritize treatment over incarceration.
- **4. 211002: Discuss** (Davis) That the Chief of Police and the Administration discuss with the Legislative Matters Committee, potential revisions to the citation form for violations of City ordinances, to include demographic data.

- Campen) That the City Solicitor work with this Council on an ordinance to deny, revoke or suspend permits to companies with a history of engaging in unsafe, hazardous or dangerous practices based on work safety histories or concerns.

- **7. 211680: Discuss** (Davis, Scott) That the City Solicitor prepare a Home Rule Petition to recognize any member of a domestic partnership as a "dependent" for Group Insurance Commission coverage, and as a "spouse" with respect to other applicable laws.
- **8. 211709: Recommend** (Niedergang) Submitting a revised Leaf Blower Ordinance regulating the use of leaf blowers.
