Dear Board Members:

Preliminary approval is recommended for the petition and plan of 2-13 Alpine Street LLC, Action Environmental Solutions PLLC, is requesting access in the City of Somerville to install four (4) groundwater monitoring wells. The proposed monitoring wells will be located; two (2) on the west side of Alpine Street, one in front of the garage at 13 Alpine Street and one in front of 17 Alpine Street near the curb in the parking lane; one (1) on the south side of Cedar Street in front of the entrance to 2 Alpine Street in the travel lane near the curb; and the final well on the city owned property between the 2 Alpine Street parking lot and the City of Somerville bike path.

This recommendation is made with reference to TCA's letter of May 15, 2015 and plan of May 11, 2015 upon stipulation that the Grant of Location is subject to: a reservation of rescission by the Board of Aldermen; indemnification of the City for all liability arising from said Grant; all permit procedures, conditions and approvals of municipal utilities; protection of existing infrastructure; and complete surface repair, restoration and maintenance. A public hearing will be required.

The proposed groundwater monitoring wells are part of an ongoing site assessment involving an environmental case with the Massachusetts Department of Environmental Protection, Release Tracking Notification Number (RTN) 3-14447 and 3-33022 for the location of 2-13 Alpine Street Somerville, MA.

The proposed groundwater monitoring wells are part of an ongoing site assessment involving an environmental case with the Massachusetts Department of Environmental Protection, Release Tracking Notification Number (RTN) 3-14447 and 3-33022.

The proposed monitoring wells will be located; two (2) on the west side of Alpine Street, one in front of the garage at 13 Alpine Street, and one in front of the house at 17 Alpine Street near the curb in the parking lane; one (1) on the south side of Cedar Street in front of the entrance to 2 Alpine Street in the Travel lane near the curb; and the final well on the city owned property between the 2 Alpine Street parking lot and the City of Somerville bike path.

Well installation activities are anticipated to take place over one day. Thereafter, the monitoring wells will be sampled no more than four times a year. Copies of the laboratory analytical certificates will be forwarded to the City of Somerville, as required by 310 CMR 40.1403(10) of the Massachusetts Contingency Plan (MCP).
