We have awarded the DREAM Program: \$3,000.00 for this service year: April 1, 2022-March 31, 2023.

As part of compliance with Federal and State requirements, the Resident Services Committee had adopted the <u>following requirements</u> which must be fulfilled in order for your agency to receive the grant awards.

- Attendance at the quarterly Provider's meeting is mandatory. A representative from your agency must be present at these to-be-scheduled meetings.
- Grants will be awarded for Somerville Housing Authority fiscal year: April 1, 2022-March 31, 2023.
- All funds must be used during that period. No invoices will be accepted after March 31st. Any remaining funds will be retained by Somerville Housing Authority.
- A quarterly report of activity with names and addresses of Somerville Housing Authority residents participating.
- Attached is the <u>Memorandum of Understanding</u>. Please sign and return the Memorandum of Understanding and return to SHA on or before April 25, 2022.

Provider Grant Memorandum of Understanding (MOU)

This Memorandum of Understanding (MOU) outlines the agreement between the Somerville Housing Authority (Grantor) and the Somerville Art Council (SAC). This agreement is to provide services for residents of SHA properties. In order to remain in compliance with this award the SAC's Mystic Mural Program must adhere to the following guidelines:

- Attendance at the quarterly Provider's meeting is mandatory. A representative from your agency must be present at each meeting.
- Grants will be awarded for Somerville Housing Authority's fiscal year: April 1, 2022 thru March 31, 2023. Please note, grant awards are distributed on a reimbursement basis for accrued expenses related to the funded program. Only activities that take place during the awarded FY will be reimbursed.
- Quarterly submissions will be reviewed by SHA for accuracy and eligibility of costs in a timely manner provided
  the quarterly submission is complete and incorporates all relevant explanatory materials and data. All information
  in the quarterly report should pertain to activities in that quarter.
- Required Reporting Information: Grantee must submit a list of SHA residents participating in the awarded program or service. Persons receiving services MUST be identifiable as a SHA residents by address or Head of Household. Supporting documentation required, i.e. sign in sheet showing resident participation, application for services or certificates of program completion. PLEASE NOTE: A quarterly report of activities MUST be submitted, even if Grantee is not requesting reimbursement.

Reporting deadlines are as follows:

2nd Quarter	July 1 - Sept 30	October 31
3rd Quarter	October 1 - Dec 31	January 31
4th Quarter	January 1 - March 31	March 31

- No invoices for FY 2022-2023 will be accepted after 30 days after the end of the Fiscal Year. Any
  remaining funds will be retained by Somerville Housing Authority.

This MOU shall be in effect from April 1, 2022 and shall end on March 31, 2023. This MOU may be terminated prior to the effective end date upon the full written approval of all the partners.
