PURCHASE AND SALE AGREEMENT

AGREEMENT made on this 24th day of June, 2016, by and between Ormond Trans Co. Inc., a Massachusetts Corporation (hereinafter "Seller") and Sadel & G Transportation, Inc. , a Massachusetts Corporation (hereinafter "Buyer").

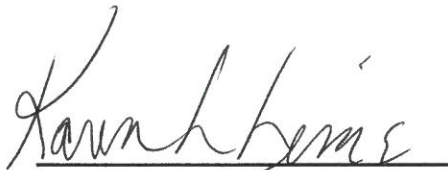
WHEREAS, the seller is willing to sell and the buyer is willing to buy a certain **MEDALLION**, Issued by the Board of Alderman, City of Somerville, being numbered **70** for the year 2016/2017 (the "Medallion"), for the sum of EIGHTY THOUSAND AND 00/100 (\$80,000.00) DOLLARS.

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein, the parties agree as follows:

1. The seller hereby warrants that said Medallion has not been pledged, mortgaged, or hypothecated to any person or entity and that said Medallion is free and clear of any and all encumbrances.
2. The Seller further warrants that there is nothing preventing Seller from selling said Medallion; that there are no outstanding court orders or judgments preventing the sale of said Medallion; that except as otherwise disclosed herein, said Medallion will be free and clear of any and all encumbrances at the time of sale, that at the time of sale, there will be no monies due thereon; and that the Seller will deliver good, clear, record, marketable title.
3. Seller shall have the right to use purchase funds to pay off any outstanding encumbrances so that good, clear, record, marketable title to said Medallion shall be delivered.
4. This sale is contingent upon approval from the City of Somerville.


5. Delivery of Medallion will be made at the time of the closing, which will take place on July 28, 2016 at 10:00 A.M. unless otherwise agreed by the parties. The sale will take place at an office mutually agreed upon by the parties.

ARTICLE I

The exact name of the corporation is:

Sadel & G Transportation, Inc.

ARTICLE II

Unless the articles of organization otherwise provide, all corporations formed pursuant to G.L. Chapter 156D have the purpose of engaging in any lawful business. Please specify if you want a more limited purpose:

To own and operate a taxi and hackney carriage license issued by the City of Somerville, including, without limitation, to purchase a City of Somerville taxi and hackney carriage license; to buy, sell, deal in, and acquire any and all motor vehicles, fixtures, merchandise or any personal property necessary to deal in and carry on a general taxi business, or engage in the business of leasing taxicabs and any medallions or other licenses or permits required by law; to borrow money for the purpose of operating and expanding the corporation's business; and to do any and all other things permissible for a corporation pursuant to applicable law and statute.

ARTICLE III

State the total number of shares and par value, * if any, of each class of stock that the corporation is authorized to issue. All corporations must authorize stock. If only one class or series is authorized, it is not necessary to specify any particular designation.

ARTICLE IV

That in the absence of shares of any class or series, the articles of organization may set forth the terms and limitations, and other provisions, relating to the shares of any class or series of stock.

ARTICLE V

The restrictions, if any, imposed by the articles of organization upon the transfer of shares of any class or series of stock are:

- a. Any shareholder who desires to transfer his stock must first offer his stock to the corporation in a signed writing;
- b. The corporation shall have a reasonable time of not more than one month to accept said offer, and one month further to obtain financing for the purchase of such stock if the offer be accepted. The corporation must accept the offer by a signed writing;
- c. If the corporation shall reject such offer, or allow more than one month to pass from the date of the offer without accepting, the selling shareholder shall next offer his stock to other shareholders of the corporation as individuals, in a signed writing;
- d. Each individual shall have one month in which to accept the offer, and one month further to obtain financing. Acceptance of such offer must be by a signed writing;
- e. If the individual shareholders to whom the selling shareholder has offered his or her stock shall reject the offer, or allow one month to pass from the date of the offer without accepting, the selling shareholder shall next offer his stock to the officers of the corporation, upon the same terms for accepting as hereinbefore set out. If none of the officers accept, the selling shareholder may then sell his stock whenever he can find a buyer;
- f. The value of the stock for such sale shall be the fair market value of the stock as determined by an independent third party mutually chosen by the seller and the corporation; and
- g. No shares of stock may be sold or transferred on the books of the Corporations until these provisions have

ARTICLE VI

Other lawful provisions, and if there are no such provisions, this article may be left blank.

The capital stock of this corporation is issued under the rules and regulations of Section 1244, Paragraph 4770 of the Internal Revenue Code.

Note: The preceding six (6) articles are considered to be permanent and may be changed only by filing appropriate articles of amendments.

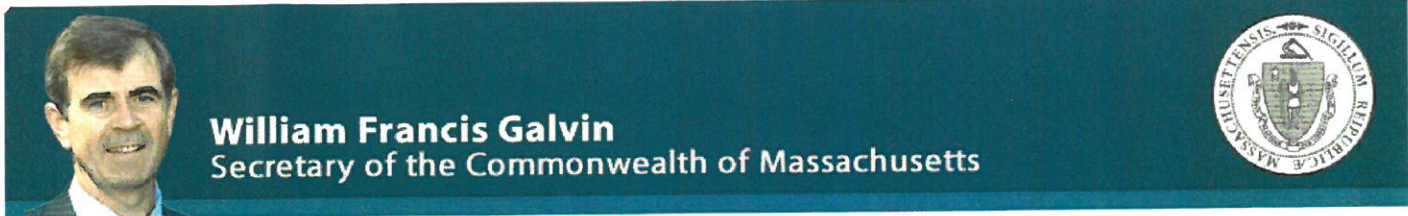
