Preliminary approval is recommended for the petition and plan of NSTAR Electric Company d/b/a Eversource to install approximately 43 feet of (2) 4-inch PVC conduit from utility pole # 219/19 to the building at 163 Glen Street. The conduit will be laid in the street on Glen Street. Glen Street is a public way in Somerville, MA.


